Objectives and Investment Policy

The Fund's objective is long term capital growth appreciation predominantly by investing in Chinese shares.

The Fund will predominantly invest (up to 100% of its assets) directly or indirectly (including through the use of financial derivative instruments) in equities (e.g. shares) and equity-related securities (e.g. certificates of deposit, preferred stocks and warrants), listed on recognised exchanges in the People's Republic of China ("PRC"), as well as in companies which are listed outside the PRC but which carry out significant business activities in the PRC.

The Fund may also gain exposure to the Chinese market by investing (up to 20% of its Net Asset Value) in debt securities (e.g. fixed or floating rate bonds issued by corporations and governments) and other debt-related securities (such as index linked debt securities). Such debt securities may embed a derivative and/or leverage and may be listed (on global recognized exchanges) and unlisted, investment grade or below investment grade and rated or unrated, secured or unsecured.

The Fund may invest up to 10% of its Net Asset Value in the units and/or shares of funds, including money market funds and exchange traded funds.

The Fund may also hold cash and ancillary assets (such as money market instruments and bank deposits). Up to 100 % of the Net Asset Value of the Fund may be held in cash or money market instruments at any time. The Fund may also invest in currencies to take exposure for investment purposes.

The Investments of the Fund will be concentrated in the Chinese market. The Fund may invest in both developed markets and markets which are still developing.

The Fund is actively managed in reference to CSI 300 Net Total Return Index USD (Bloomberg: CSIN0301 Index) by virtue of the fact that the

investment objective of the Fund is to outperform the Benchmark and performance fees are calculated on out-performance of the Fund against the Benchmark. The Investment Manager has discretion to invest in securities not included in the Benchmark at any time in order to take advantage of investment opportunities. The investment strategy will restrict the extent to which the Fund's holdings may deviate from the Benchmark. This deviation may be limited. There is a tracking error target between 2-^% depending on market opportunities.

The Fund intends to measure its performance against the CSI 300 Net total return index USD (Bloomberg: CSIN0301 Index), which is a capitalisation-weighted stock market index designed to replicate the performance of the top 300 stocks traded in the Shanghai and Shenzhen stock exchanges

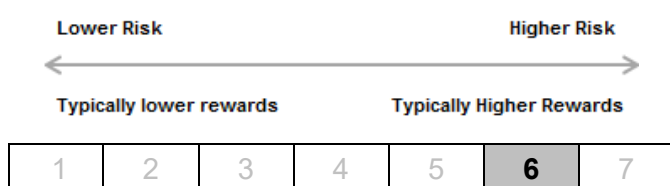
The Fund may utilise financial derivative instruments (swaps, futures, forwards and options.) for efficient portfolio management purposes and/or hedging purposes. Derivatives may be traded on a recognised exchange or over-the-counter. Any income arising from the Fund will be reinvested and it is not intended that the Fund will pay dividends.

The Fund employs a long-term investment approach and is suitable for investors with a higher risk profile.

You may buy and sell shares in the Fund on any day which is a Business Day in Ireland unless such day is also a public holiday in China.

In addition to the risk captured by the indicator, the overall Fund value may be considerably affected by:

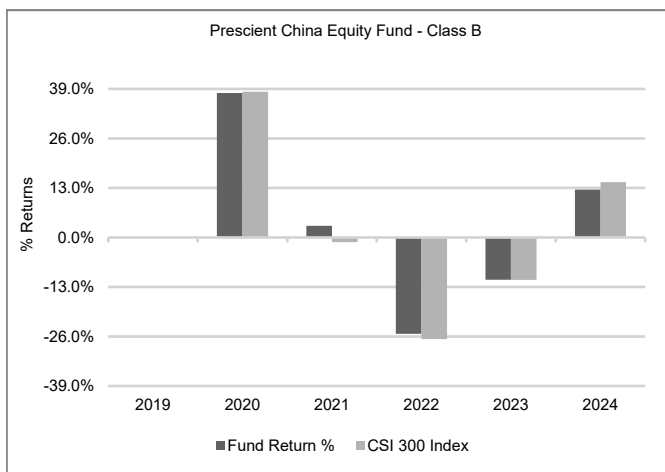
There is no charge for switching between sub-funds up to a maximum of four times per annum. Shareholders who switch on more than four occasions per annum may be subject to a charge of Euro 40 per switching transaction.

The ongoing charges figure is an estimate based on a projection of the expenses of the Fund for the first twelve months of operation of the Fund. This figure may vary from year to year. It excludes portfolio transaction costs, except in the case of an entry or exit charge paid by the UCITS when buying or selling units in another UCITS or collective investment undertaking.
