Objectives and Investment Policy

The Fund's objective is to achieve long term capital growth appreciation, by investing predominantly in mainland Chinese equities, bonds, cash, money market instruments and derivatives.

The Fund may also invest in global equities, bonds cash, money market instruments and derivatives. Chinese geographical exposure may also be gained via securities including but not limited to derivatives, exchange-traded Funds and Regulated Funds traded on exchanges having obtained full membership of the World Federation of Exchanges.

The Fund may use derivatives to manage the risk profile of the Fund, for example to reduce the impact of price or exchange rate movements. The Fund may also invest in global currencies directly or through the use of financial derivatives. The currencies chosen by the Fund will mainly be with stable economies to reduce risk.


The Investment Manager has discretion in managing the assets of the Fund. Asset allocation will tend to be higher in equities, which are chosen to deliver growth but can be reduced at the discretion of the Investment Manager.

In relation to investment in interest bearing securities, 90% of such investments shall have a credit rating or an implied credit rating of "investment grade" at the time of investment or shall be made with issuers who have a credit rating or an implied credit rating of "investment grade" at the time of investment, by Standard & Poors, Moody's or Fitch Ratings Limited.

Whilst investment grade securities potentially produce a lower level or income than non-investment grade securities they are considered to be lower risk.
